## Terms & Conditions

### 1 Payment Terms

We accept VISA / MasterCard payments and international bank transfers. Confirmed booking can be made with a non-refundable 10% deposit, payment in full to be made 30 days prior to the start of the event. Last minute bookings can be made subject to space being available and full payment by credit card.

### 2 Cancellations

Cancellations made less than 30 days before the start of the event will also attract an additional 10% charge to cover our costs. Cancellations made more than 30 days will incur no additional costs over and above the deposit already charged.

### 3 Amendments

Amendments to the desired bike and dates can be made at any time up until 1 week before the start of the event subject to availability and full payment having been received.

### 4 Riding Equipment

You must wear suitable protective clothing whilst using the bikes & facilities of HighSideTours. Riding in sandals, T Shirts or similar clothing is not permitted. No bikes other than those provided by HighSideTours may be used at the circuit.

### 5 Insurance

You are not insured for any damage you may do to yourself whilst attending our events, and it is your responsibility to ensure that you are fit to ride and are not suffering from any medical problems that may affect your ability to ride a motorcycle. You will be required to sign a declaration & indemnity to this effect prior to the commencement of activities.

We strongly advise you to obtain your own travel insurance for all events. This should cover you for things like medical costs, flight cancellations or delays, theft, sickness, and other unforeseen events. For EU citizens a suitable policy can be found at [HBInsurance](#). HighSideTours tracks days are a level 3 activity under this plan.

### 6 Security Deposit

A deposit of US\$500 (this is the standard fee and may be higher for some bikes) is required prior to the commencement of activities. This can be paid in advance by credit/debit card, cheque or bank transfer. We will pre-authorise this amount on your credit card and will refund the balance after crash damage, if any, at the end of the event.

### 7 Crashes

A crash is defined as an incident whilst the bike is in your hands, which causes more than minor damage. We don't count scratches or engine casing scars as damage. The cost of the first crash is not deducted from your security deposit providing you are riding normally. If, in the opinion of the track marshals or staff, you have caused the damage due to inappropriate or dangerous riding you will be charged.

The costs of any second (or subsequent crashes) will be assessed at the end of the session and will be applied against your security deposit. If the balance exceeds your deposit and you wish to continue we ask for an increased amount to cover the additional costs & a further security deposit amount. If you are constantly crashing or endangering the other riders and bikes HighSideTours reserves the right to bar you from any further participation with no refunds.

### 8 Personal Injury

HighSideTours has an ambulance and first aid staff at the circuit for the duration of each event. In the unlikely event that you are injured during the event HighSideTours will, if appropriate, transfer you to a hospital for treatment. HighSideTours will not meet the costs of any treatment given and if you are not in a position to do so will authorise the required treatment on your behalf.

### 9 Details subject to change

We make every effort to ensure that all events are provided as advertised & described, however, there may be circumstances beyond our control that force us to make alternative arrangements. We therefore reserve the right to make any changes we deem necessary to facilitate the event, but we will always strive to provide alternatives that are equivalent to those originally offered.
